1. MBBS recognized by MCI.
2. Should be registered with Delhi Medical Council (DMC).
3. Only those candidates who have completed internship by 31.03.2024 may apply.
4. Those who have already completed/doing Non-PG Junior Residency in Pulmonary Medicine for more than 06 months in any other institutions are not eligible.
5. Candidate who has completed Non-PG Junior Residency of one year in any other discipline need not apply.
6. The applicant should not be more than 30 years of age at the time of interview.
7. Age relaxable for SC/ST/OBC/PwD candidates is applicable as per rules.

**Emoluments:** Pay matrix level-10 in 7<sup>th</sup> CPC + other allowances admissible as per rules.

**Terms & Conditions:**

- a. Eligible candidates may appear for registration at 9:30 a.m. on above said date alongwith completed application in prescribed format in the Office of the Director, V.P. Chest Institute, University of Delhi, Delhi-110 007.
