Eligibility:

- MBBS recognized by MCI.
- 2. Should be registered with Delhi Medical Council (DMC).
- Only those candidates who have completed internship by 30.09.2020 may apply.
- Those who have already completed/doing Non-PG Junior Residency in Pulmonary Medicine for more than 06 months in any other institutions are not eligible.
- 5. Candidate has completed Non-PG Junior Residency of one year in any other discipline need not apply.
- 6. The applicant should not be more than 30 years of age at the time of interview.
- 7. Age relaxable for SC/ST/OBC/PwD candidates is applicable as per rules.

Emoluments: Pay matrix level-10 in 7th CPC + other allowances admissible as per rules.

Terms & Conditions:

- a. Eligible candidates may appear for registration at 9:30 a.m. on above said date along with completed application in format in the Office of the Director, V.P. Chest Institute, University of Delhi, Delhi-110 007. They shall also require to submit a non-refundable fee of Rs.500/- drawn in the form of a DD in favour of "Director, VPCI", payable at Delhi (Rs.250/- in case of SC/ST candidates). No fee is chargeable for the persons with disabilities (PwDs). No application will be registered after 10:30 a.m.
- b. Prescribed application form is available on the Institute's website: www.vpci.org.in
- c. <u>Tenure</u>: Maximum two terms of six months each. The initial appointment will be for six months only which may be extended on satisfactory recommendation from concerned Head of the Department.
- d. Other service conditions will be applicable as prescribed by the Government of India/University of Delhi from time to time.
- e. Candidate seeking benefit of reservation are required to submit certificate regarding their caste, PwD, status & Non-creamy Layer certificate in respect of OBC as applicable & as per the prescribed format issued by Govt. of India.
- f. The candidate must bring following original certificates with self-attested copies at the time of registration/interview:
 - Certificate in support of age (10th certificate)
 - ii. Certificates in support of educational qualifications
 - iii. Mark sheets of MBBS Part I, II & final year.

 - k. Selected candidates will be required to appear before standing Medical Board of VPCI/Govt. Body for Medical Fitness before joining (failing which joining will not be possible).
 - I. Resignation will not be accepted before completion of three months service from the date of joining, failing which no experience certificate will be issued for the service rendered in the Institution.
