## CIRCULAR

Sub: Allowing another opportunity to exercise/re-exercise option for pay fixation - reg.

With reference to the University of Delhi's circular no.Estab.II(i)/004/7<sup>th</sup> CPC/2018/993 dated 09.08.2023 and in terms of the Department of Expenditure, Ministry of Finance, Government of India O.M. No.4-21/2017-IC/E.IIIA dated 04.07.2023 on the subject matter, the Competent Authority has approved for allowing another opportunity to the employees of the Institute to exercise/re-exercise option for pay fixation within a period of three months from the date of issue of Department of Expenditure, Ministry of Finance, GOI's OM dated 04.07.2023 i.e. 3<sup>rd</sup> October, 2023, as allowed under O.M. Ref.No.4-21/2017-IC/E.IIIA dated 28.11.2019 of Department of Expenditure, Ministry of Finance, Govt. of India.

The Department of Expenditure, Ministry of Finance, Government of India vide OM dated 28.11.19 directed to invite the attention to Rule 10 of the CCS (RP) Rules, 2016 which provides for the entitlement of employees for drawal of annual increment either on 1<sup>st</sup> January or 1<sup>st</sup> July depending on the date of appointment, promotion or grant of financial upgradation. The Sub-Rule (2) thereof provides that increment in respect of an employee appointment or promoted or granted financial upgradation including upgradation under MACPS during the period between 2<sup>nd</sup> day of January and 1<sup>st</sup> day of July (both inclusive) shall be granted on 1<sup>st</sup> day of January and the increment in respect of an employee appointed or promoted or granted financial upgradation under MACPS during the period between the 2<sup>nd</sup> day of July and 1<sup>st</sup> of January (both inclusive) shall be granted on 1<sup>st</sup> day of July, provided a period of 6 months qualifying service is strictly fulfilled. The next increment thereafter shall, however, accrue only after completion of one year.

The employees who have been regularly promoted or granted financial upgrdation on or after 01.01.2016 and desire to exercise/re-exercise their option for pay fixation under FR22(I)(a)(1) shall be given an opportunity to exercise or re-exercise of the option thereunder as per the above OM and may submit the option to the Administration Section for the same latest by 3<sup>rd</sup> October, 2023. No further request for extension of date or relaxation of condition in exercising of option will be entertained under any circumstances. The option form of exercise/re-exercise is printed overleaf.
