Scheme for the year 2024-25 and Constitution of a team for internal assessment.

The Ministry of Health & Family Welfare, Government of India has launched "Kayakalp" initiative to recognize efforts under "Swachh Bharat Abhiyaan" for central government hospitals/institutes with a view to maintaining the highest level of cleanliness & hygiene for preventing infections and providing the patients and visitors with a positive experience with the following objectives –

 To promote high degree of cleanliness, hygiene and infection control practices in public Health Care facilities.

ii) To incentivize and recognize such healthcare facilities that show exemplary performance in adhering to standard protocols of cleanliness and infection control.

To inculcate a culture of on-going assessment and external review of performance related to hygiene, cleanliness and sanitation in Central Government Hospitals/Institutions.

iv) To create and share sustainable practices related to improved cleanliness in Central Government Hospitals/Institutions linked to positive health outcome
