3. This tender document is not transferable. The tendered work, if awarded, is not transferable.
4. The successful Bidder has to submit a Performance Guarantee amount equal to 3% of quoted amount in the form of Demand Draft/FDR/Bankers Cheque in favour of "Director - V.P. Chest Institute". The performance guarantee will be released after submission of completion certificate of work.
5. The site may be inspected in all working days & hours.
6. VPCI reserve the right to accept or reject any or all tenders without assigning any reason whatever it may be.
7. The incomplete tenders are liable to be rejected without assigning any reason.
8. The rates of GST will be applicable in VPCI as applicable to Civil works.
9. The Tenderers should quote the percentage in less or excess in the BoQ from the Estimated Amount.
10. The work should be completed in 90 days from the date of award of work order.
