- 3. This tender document is not transferable. The tendered work, if awarded, is not transferable.
- 4. The successful Bidder has to submit a Performance Guarantee amount equal to 3% of quoted amount in the form of Demand Draft/FDR/Bankers Cheque in favour of "Director V.P. Chest Institute". The performance guarantee will be released after submission of completion of warranty period.
