

2. The Tender shall remain open for acceptance for one hundred and eighty (180) days from the date of opening of tenders by the Vallabhbhai Patel Chest Institute (VPCI). The time limit for acceptance may be extended by VPCI at its discretion for such further period, as it may notify.
3. This tender document is not transferable. The tendered work, if awarded, is not transferable.
4. The successful Bidder has to submit a Performance Guarantee amount equal to 3% of quoted amount in the form of Demand Draft/FDR/Bankers Cheque in favour of "Director - V.P. Chest Institute". The performance guarantee will be released after submission of completion certificate of work.
5. The site may be inspected in all working days & hours.
6. VPCI reserve the right to accept or reject any or all tenders without assigning any reason whatever it may be.
7. The incomplete tenders are liable to be rejected without assigning any reason.
8. **The rates of GST will be applicable in VPCI as applicable to Civil works.**
9. **The Tenderers should quote the percentage in less or excess in the BoQ from the Estimated Amount.**
10. The work should be completed 180 days from the date of award of work order.
11. The overall lowest amount will be considered as L1
12. CPWD norms will be followed.
13. Manual bids shall not be accepted.
14. The Tender Fee and EMD are accepted in the form of FDR/DD/Bank Guarantee/Banker's Cheque from any of the Commercial Banks, in favour of "Director VPCI".
