**TERMS & CONDITIONS**

**1. Scope of Work/Contract**

The empaneled Hospital/Diagnostic Centre shall provide the following services to the patients admitted in Viswanathan Chest Hospital (VCH) at Vallabhbhai Patel Chest Institute (VPCI) under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) at CGHS/AIIMS Rates:

**1.1 Laboratory Investigations**

The facility must be capable of conducting:

- **Haematology** - Complete Blood Count (CBC), Peripheral Smear, Bone Marrow Studies, etc
- **Biochemistry** - Blood glucose, Lipid Profile, Liver Function Tests (LFT), Kidney Function Tests (KFT), Electrolytes, etc.

- **Microbiology** – Culture & Sensitivity, Gram Staining, AFB Smear, Urine Culture, Blood Culture, etc.
- **Immunology** – Antibody & Antigen detection tests, Rheumatoid Factor, ANA Panel, etc.
- **Serology** – HIV, HBsAg, Anti-HCV, VDRL, Widal Test, etc.
- **Cytology** – Pap Smear, Body Fluid Cytology, etc.
- **Histopathology** – Tissue Biopsy examination, H&E staining, Immunohistochemistry
- **Molecular Diagnostics** – RT-PCR, Real-time PCR, Gene Sequencing (NGS), DNA/RNA Panels, Viral Load Testing

### 1.2 Radiological Investigations

The facility must have capability for:

- **X-Ray** – Chest, Abdomen, Spine, Extremities, Fluoroscopy, etc.
- **Ultrasound** – Abdomen, Pelvis, Vascular, Echocardiography, etc.
- **CT Scan** – High-resolution CT (HRCT) of Chest, Abdomen, Head, Spine, Extremities, etc.
- **MRI** – Brain, Spine, Abdomen, Pelvis, Extremities, etc.
- **PET Scan** – (If available at facility)

### 1.3 Specialized Diagnostic Services

- **Cardiology**: ECG, Echocardiography (2D/3D), Treadmill Test (TMT), Holter Monitoring, etc.
- **Pulmonology**: Pulmonary Function Test (PFT), DLCO (Diffusion Lung Carbon Monoxide), Sleep Studies, Bronchoscopy (if applicable)
- **Endoscopy Services**: Upper GI Endoscopy, Colonoscopy, Bronchoscopy (as applicable)
- **Other Specialized Diagnostics**: As when required by VPCI on case-to-case basis

### 1.4 Service Requirements

The empaneled facility shall adhere to the following service standards:

- **Cashless Diagnostic Services** – All investigations shall be provided on a cashless basis under PM-JAY
- **Report Delivery** – Reports shall be delivered within stipulated timelines as mutually agreed (typically within 24-48 hours for routine tests, urgent reports within 6 hours)
- **24x7 Emergency Diagnostics** – Emergency diagnostic services available on-call basis for critical patients
- **Digital Report Sharing** – All test reports must be shared with VCH, VPCI in both digital and hard copy formats
- **Sample Collection** – Facility-based sample collection from VCH, VPCI wards or designated collection centers
- **Quality Assurance** – Compliance with ISO 15189 standards for laboratory medicine
- **Data Security** – Secure storage and handling of patient data as per HIPAA/GDPR guidelines
- **Ambulance Service** – 24x7 availability of fully equipped emergency ambulance services for immediate transport and stabilization of critically ill patients.

## **2. Eligibility Criteria**

Participating Hospitals/Diagnostic Centers must fulfill all the following mandatory requirements:

### **2.1 Accreditation**

- **Valid NABL Accreditation** (National Accreditation Board for Testing and Calibration Laboratories) for Laboratory Services as per ISO 15189:2022
- **Valid NABH Accreditation** (National Accreditation Board for Hospitals and Healthcare Providers) for Hospital/Diagnostic Centers
- Accreditation certificate must be current and valid at the time of bid submission

### **2.2 Statutory Licenses & Approvals**

The facility must possess:

- **AERB Approval** (Atomic Energy Regulatory Board) for Radio diagnostic Centers (mandatory for X-Ray and other radiological services)
- **PCPNDT Registration** (Pre-conception and Pre-natal Diagnostic Techniques) where applicable
- **Biomedical Waste Management Authorization** as per relevant Government rules
- **Fire Safety NOC** (No Objection Certificate) from competent authority
- **Pollution Control Board Clearance** (if applicable)
- **BSL-2/BSL-3 Certification** for Microbiology Laboratory (where applicable)

### **2.3 Operational Experience**

- **Minimum 3 Years of Continuous Operation** as a diagnostic facility
- Experience with Government/PSU healthcare schemes preferable
- No record of significant complaints or adverse incidents

### **2.4 Location**

- Facility must be located **within a radius of 0 to 10 kilometers** from VPCI premises (Delhi-110007)
- Easy accessibility for patients and VPCI representatives
- Adequate parking and patient amenities

### **2.5 Rate Compliance**

- Must provide all services strictly at **CGHS/AIIMS rates** (2023 or latest versions, whichever is lower)
- No additional charges except GST where applicable
- Rate schedule to be submitted with bid

### **2.6 Qualified Manpower**

The facility must maintain:

- **Qualified Pathologist(s)** with relevant qualification and registration (minimum MD/DNB)
- **Qualified Radiologist(s)** for radiological services (minimum MD/DNB/FRCR)

- **Trained Technicians** with relevant certifications (DMLT/B.Sc. MLT/CT Tech)
- Sufficient staffing to ensure 24x7 coverage for critical tests

## 2.7 Equipment & Infrastructure

- **Modern, Calibrated Equipment** with valid calibration certificates
- **Annual Maintenance Contracts (AMC)** for all major diagnostic equipment
- **Uninterrupted Power Supply** with battery backup and generator

## 2.8 Non-Blacklisting




#### **5.2 Performance Standards**

The empaneled facility shall:

- Provide emergency diagnostics within 6 hours of request
- Deliver routine report within 24-48 hours of sample receipt
- Maintain 100% quality compliance with NABL/NABH standards
- Undergo regular compliance audits by VPCI

#### **5.3 Rate Compliance**

- All services shall strictly be provided at CGHS/AIIMS rates (2023 or latest), whichever is lower
- Any deviation from agreed rates shall result in penalty/contract termination
- Rate updates to be reviewed annually with mutual consent
- No hidden charges or supplements without prior approval



VPCI intends to empanel accredited hospital/diagnostic/pathology/radiology centers to provide diagnostic services to patients admitted in the Viswanathan Chest Hospital (VCH) at Vallabhbhai Patel Chest Institute (VPCI) under **Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) at CGHS/AIIMS rates**, whichever is lower.
2. The Service Provider has been selected through an e-tendering process and has fulfilled all eligibility criteria, including accreditation, statutory compliance, manpower, equipment standards, and operational capability.
3. Both parties now agree to enter into this Agreement for the provision of diagnostic services on the terms and conditions set forth herein.

**NOW THIS AGREEMENT WITNESSETH AS UNDER:**

**1. SCOPE OF SERVICES**


The Empaneled Facility shall provide the following categories of services to VPCI beneficiaries under AB-PMJAY:

**1.1 Laboratory Investigations**

Hematology, Biochemistry, Microbiology, Immunology, Serology, Cytology, Histopathology, Molecular Diagnostics and any other tests prescribed by VPCI clinicians.

**1.2 Radiological Investigations**

X-Ray, Ultrasound, CT scan, MRI, PET Scan (if available) and other radio diagnostic services as required.



### 1.3 Specialized Diagnostic Services



Neither party shall be liable for non-performance due to circumstances beyond control (natural calamities, pandemic, war, etc.). Written intimation must be given within 48 hours.

## **14. AMENDMENTS**

Any amendment to this Agreement must be made **in writing** and signed by authorized representatives of both parties.

## **15. ENTIRE AGREEMENT**

This Agreement, along with tender documents, bid submission, declarations, undertakings, and annexures forms the **entire contract** between VPCI and the Service Provider.






