8. The packages of Medicines will indicate the name of the manufacturer, the date of manufacture, date of expiry and the batch no. The labels both on Innermost packing and outer Containers should be marked with the words "VPCI SUPPLY NOT FOR SALE" in bold letters.
9. Medicine/Drugs where expiry date is less than 6 months must not be supplied without obtaining approval for supply from competent authority along with undertaking to receive back in case of non-usage.
10. The quantity of drugs/Medicines are to be supplied in part as per the requirement of the User Department.
11. If any of the supplied Medicines are not utilized before the expiry date, the supplier should undertake to replace with fresh stock of medicines as and when required
12. The Medicines are related to health of the patients hence the condition for prior turnover and prior experience may not be relaxed for start-ups as per as per office memorandum no. F.20/2014-PPD(Pt) dated 20.09.2016 issued by Ministry of Finance (Department of Expenditure). The Manufacturer/Supplier/Firms/Distributor/Stockist have turnover less than 1.00 crore in last three financial year i.e. 2021-22, 2022-23 & 2023-24 do not submit bid otherwise bid will be summarily rejected.
13. Any clarifications/queries relating to the tender document and the terms and conditions contained therein should be raised only through GeM Portal. Clarification/queries raised from modes other than the GeM Portal will not be entertained.
14. **Bid Security/Earnest Money Deposit**
  1. **Earnest Money Deposit of Rs. 97,000.00 (Rupees Ninety Seven Thousand only)** in the form of Account Payee Demand Draft/ any other accepted instrument from any of the public sector banks drawn in favour of the 'Director, V.P. In such case the VPCI reserves the right to purchase the same supply from the subsequent bidder at the risk & cost of tenderer who may face appropriate action.
18. The Batch No., Date of Manufacturing & Date of Expiry should be mentioned on all bills & challans. All medicines supplied against one bill should have Batch No., Date of Manufacturing & Date of Expiry etc., failing which the company will be debarred for next two years. In the event of a company supplying expired medicines to VPCI the company can be debarred for the next two years.
19. It should be taken into account by the tenderers that if the VPCI decides to get the supplies analyzed from a reputed Test Lab then they will be bound by the action taken by the Institute on such analysis reports.
20. If any Manufacturer/Supplier/Firms/Distributor/Stockist is black listed in any State/Union Territory of India, it should be treated as black listed. If this fact is concealed, tender will be deemed to be cancelled automatically & will be liable for Departmental legal action/penalty.
21. The VPCI reserves the right to reject any or all tenders without assigning any reason at any stage.
22. All Legal matters/cases, if any arising out of conditions of tender, will be subject to the jurisdiction of the NCT of Delhi only.
23. In the event of tie in two or more firms in financial bid, then the highest value of cumulative gross turnover of last (03) financial year i.e. 2021-22, 2022-23 & 2023-24 shall be decided to award of Contract/Purchase Order..
24. Bank account number, Banks name, its branch and IFSC number of the vendors to be mentioned as per **Annexure-V** for refund of EMD/Payment of invoices.
25. Manufacturer/Supplier/Firms/Distributor/Stockist outside the city should mention their convenient Delhi address, name & mobile number of the contact person in their tender form.
26. Any alteration in price and misrepresentation will not be allowed at any stage.
27. In case there is any calculation mistake in unit pack from the vendor either the amount of bulk pack will be considered as quoted rate and unit pack to be ignored or the tender for that particular item will stand cancelled.
28. Financial bids of eligible and technically qualified bidder will be opened. The lowest quoted rate of each item (medicine/drug as per tender document/financial bid) by the bidder/s in the financial bid will be considered for awarding of Purchase Order.
29. The VPCI reserves the right to accept or reject any bid and to annul the process and reject all bids at any time, without assigning any reason or incurring any liability to the bidders. No claim whatsoever will be entertained/paid by the Institute to the bidder(s).
30. If the bidder proposes any alternation in or additions to the prescribed form of tender or decline to carry out any work of the tender document; or any conditions mentioned, etc., his tender

der is liable to be rejected.

31. Before the deadline for submission of tender, the VPCI may modify the tender document by issuing addendum/corrigendum. 33. Payment Mode: After, the award of the contract, the vendor has to submit the bill after supplies. The Payment will be released through RTGS/NEFT/ECS.
