1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality

and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1.	The System should be able to record the Pulse, respiration, Bio-potential like (EEG, ECG, EMG, etc), Invasive BP, NCV, Spirometry (1 Liter/min differential flow head for rodents) along with flow sensors capable of measuring flow ranges suitable for rats and mice. Non-invasive blood pressure (NIBP) transducer for rat and mice. The system should be able to provide calculated and derived parameters such as HRV, Peak analysis and Pulse transit time.

2.	Software with step-by-step instructions, protocol and experimental design for performing various experiments in physiology teaching applications. Also, should have sample data for animal experiments for demonstrating to the students.
3.	Number of inputs at-least 4 channels.

4.	At-least 2 amplifiers for recording bio-potentials & 2 general purpose amplifiers channels.
5.	The ADC resolution of data acquisition s hould be 16 bits or more
6.	Inbuilt Isolated stimulation unit capable of generating user defined various wave types, and should be able to offer either a voltage stimulator with 0-10 V output range or a current stimulator with 0-20mA current range or both with pulse duration range 0.1-100ms, integrated and synchronized with software.
7.	Data Sampling frequency more than 1000 Khz and linked to computer should be through any high-speed data transfer interface (ethernet, USB or equivalent)
8.	Facility for recording ECG leads (I, II, III) along with real time/ offline ECG analysis software for calculating cardiac axis with vector cardiograph and other derived parameters like aVL, aVF, aVR etc.
9.	Isometric/Force Transducer (0-50g) for in-vitro studies.
10.	The software should have the facility to edit and custom designed the experiments as per the requirements of the user department. Like Content (text, video, picture audio, Questionnaire etc, could be embed easily in the experiment) to generate modern teaching tools for the students (preferred), Editing can be done online/offline using laptop/ tablets/ mobile phones.
11.	User friendly software for recording, analyzing and printing the data, the software should allow calibration of transducers, display of actual values, controllable gain, filter settings, baseline setting for event marking and annotation. 12.	The Software should have analysis modules for ECG, BP, HRV, Peak Analysis, Spirometry parameters. Users can select flow units as either $\mu\text{L/s}$, mL/s or L/s .
13.	ECG module should generate graphs on line/offline (QT/RR Plot, QT/Time Plot, RR/Time Plot, waterfall plot etc).
14.	HRV analysis module/software should generate online/offline graphs like Tachogram Plot, RR histogram Plot, Delta RR Histogram Plot, Poincare plot, Power Spectral Plot etc. with the HRV analysis report with time domain, frequency domain and non-linear parameters.
15.	The data can be exported to MATLAB and EXCEL
16.	Compatible NIBP monitor with rat and mice transducers (Qty-1 each)
17.	The NIBP system should be Tail Cuff method based on latest/advanced non-invasive technology to precisely record systolic, diastolic and MAP, HR, tail Blood flow and core temperature from rat and mice.

All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
