Chest Institute, University of Delhi, Delhi-110 007. The interested candidates shall also require to submit a non-refundable fee of Rs.500/- drawn in the form of a DD in favour of "Director, VPCI", payable at Delhi. No fee is chargeable from the persons with disabilities (PwDs). No application will be received after 10:30 a.m.
- The applicant should not be more than 33 years of age at the time of interview (relaxable for reserved candidate is applicable as per GOI rules).
