General Instructions to Applicants

- 1. Those applicants who have already applied against the advertisement no.davp17169/11/0018/2021 published in the Employment News dated 14-20 November, 2020 and subsequent corrigendum no.davp 17169/11/0011/2122 published in the Employment News dated 23-29 October, 2021 need not apply again. Their applications will be considered as per their eligibility mentioned in their applications. However, if they wish to apply for any other post as a fresh applicant other than the one they have previously applied, they may apply afresh.
- 2. A separate application form has to be submitted for each post. Application form available on the Institute's website i.e. www.vpci.org.in.
- 3. Before filling up the form, candidates are advised to carefully go through the advertisement available on the Institute website and confirm their eligibility with regard to qualification/experience/age etc., before submitting the application form.
- 4. Consequent upon adoption of self-certification provisions as required by the Govt. of India, the Institute shall process the application entirely on the basis of information/ documents submitted by the candidates. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall lie solely with the applicant and the applicant shall be liable for action as per law. - 5. Candidates should possess the prescribed educational qualification and experience before filling the form or as on last date. - 7. All the posts except Nursing Officer will be filled as per the Recruitment Rules of the University of Delhi. The qualifications and other service conditions shall be such as prescribed by the University of Delhi from time to time. The post of Nursing Officer will be filled as per Recruitment Rules of the Institute.
- 8. The upper age limit prescribed for direct recruitment shall be relaxable in case of candidates belonging to the reserved categories in accordance with the instructions received from the Government of India in this regard from time to time as applicable to Central Government establishments.

- 9. 
