In light of the DU's letter dated 10.03.2025 regarding non-applicability of age relaxation to outsourcing/project's staff as per the Recruitment Rules (Non-Teaching Employees) 2020, all concerned applicants are informed that the Screening Committee of VPCI after re-scrutiny of the applications received against the advertisements published in Employment News on 14-20 November, 2020, 23-29 October, 2021 and 27th May – 2nd June, 2023 to the post of Technical Assistant {UR-7, PwBD-1 [OBD(ID)]} for recruitment on regular basis in pay matrix level-5 in 7th CPC found the 229 applicants are eligible (Annexure-I) and 214 applicants are not eligible (Annexure-II) for written test for the post of Technical Assistant {UR-1, PwBD-1 [OBD(ID)]}.
